Note: Written appeals must be received before the close of the public hearing April 9, 2018.

My name is Vickie Puetz. My husband is William Puetz. We own a home at 4305 Seaway Drive, Lansing Mi, in "Glenburne Commons" Subdivision.

I was just notified from my son that there will be a hearing on April 9th re: Special Assessment Roll #GB-2017 for grass cutting and trash cleanup charges. Our portion being \$75.79.

We are gone for the winter and will not be home until the 1st of May.

Our property backs up to a small portion of the Commons on the south side, along with about 10 other homes. One of these homes belongs to a homeowner that lives on Glenburne Avenue who is using the Commons area for his own personal use. I have been in touch numerous times with Adam Hussain regarding the condition of this part of the Commons, because this particular homeowner stores old non-running vehicles, junk, a canoe and a lot of miscellaneous junk in the Commons. He uses at least half of the Common area to plant corn, a huge garden for his personal use (not a community garden). Burns firewood at night in the Common area when everybody goes to bed. Plus stores HUGE piles of firewood in the Common area, which has become home to skunks and raccoons, and as of last spring has even made a lean-to that is built attached to a fence (not his fence), on the Commons side, which he keeps all his garden tools and more wood inside.
