Starting at the intersection of N. Martin Luther King Jr. Blvd. and Sheridan Rd. go south on N. Martin Luther King Jr. Blvd to the Grand River, southeast on the Grand River to N. Grand River Ave., north on N. Grand River Ave. to W. North St., southeast and east on W North St. and E. North Street to CSX North America Railroad Track, southeast on CSX North America Railroad Track Railroad Track, to N. Larch St., north on N. Larch to McKinley St., east on McKinley St. to N. High St., north on N. High St. to Lake Lansing Rd., northeast on Lake Lansing Rd. to Lansing's City Limit, north on Lansing's City Limit to Sheridan Rd. and continue west on Sheridan Rd. to the point of beginning.

Precinct 02

Starting at the intersection of CSX North America Railroad Track Railroad Track and N. Larch St. to northwest on CSX North America Railroad Track Railroad Track to E North St., west on E. Hayford Ave., east along Lansing's City Limit next to Tulane Dr., south and east along Lansing's City Limit to the intersection of Lansing's City Limit and US-127, north on US-127 to Lansing's City Limit, then west then north then west on Lansing's City limit to the point of beginning.

Precinct 04

Starting at the intersection of Lake Lansing Rd. and Lansing's City Limit go southwest on Lake Lansing Rd. to N. High St., south on N. High St. to McKinley St., west on McKinley St. to N. Larch St., south on N. Larch St. to E. Oakland Ave., east on E. Oakland Ave. to N. Pennsylvania Ave., south on N. Pennsylvania Ave. to E. Saginaw St., east on E. Saginaw St. to Marshall St., north on Marshall St. to E. Grand River Ave., east on E. Grand River Ave. to Wood St., north on Wood St. to David St., west on David St. to the intersection of David St. and Lansing's City Limit, north on Lansing's City Limit to the point of beginning.

Precinct 05

Starting at the intersection of E. Grand River Ave. and N. Foster Ave., go south on N. Foster Ave. to E. Michigan Ave., east on E. Michigan Ave. to S. Clippert St., south on S. Clippert St. to E. Kalamazoo St. and Lansing's City Limit, beginning east on the Lansing's City Limit follow Lansing's City Limit until it meets US-127, south on US-127 to Lansing's City Limit, then following Lansing's City Limit south and west and north and west and north and west to the point of the beginning

Precinct 06

Starting at the intersection of Fernwood Ave. and N. Clemens St, go south on N. Clemens St. continuing on S. Clemens Ave. to the CSX North America Railroad Track, southeast on the CSX North America Railroad Track to the Red Cedar River, northeast on the Red Cedar River to Lansing's City Limits at the extension of Mifflin Ave., north along Lansing's City Limits to E. Michigan Ave., west on E. Michigan Ave. to N. Foster Ave., north on N. Foster Ave. to Fernwood Ave., west on Fernwood Ave. to the point of beginning.

Precinct 07

Starting at the intersection of E. Saginaw St. and N. Pennsylvania Ave. go south on N. Pennsylvania Ave. to E. Michigan Ave., east on E. Michigan Ave. to N. Clemens Ave., north on N. Clemens Ave. to Fernwood Ave., east on Fernwood Ave. to N. Foster, north on N. Foster to E. Grand River Ave., west on E. Grand River Ave. to Marshall St., south on Marshall St. to E. Precinct 08

Michigan Ave., west on E. Michigan Ave. to the point of beginning.

Precinct 09

Starting at the intersection of S. Cedar St. and I-496 go south on S. Cedar St. to Christiancy St., east on Christiancy St. to Linval St., south on Linval St. to E. Mount Hope Ave., east on E. Mount Hope Ave. to S. Pennsylvania Ave., north on S. Pennsylvania Ave. to the Red Cedar River, southeast and then northeast on the Red Cedar River to the CSX Transportation Railroad Track, northwest on the CSX Transportation Railroad Track to I-496, west on I-496 to the point of beginning.

Precinct 10

Precinct 15

Starting at the intersection of Maplehill Ave. and Wildwood Ave., go south on Wildwood Ave. to Spokane Ave., west on Spokane Ave. to Louis St., north on Louis St. to Cedar Ct., west on Cedar Ct. to S. Cedar St., south on S. Cedar St. to E. Jolly Rd., east on E. Jolly Rd. to the Norfolk Southern Railroad Track, northwest on the Norfolk Southern Railroad Track to the Hilliard Drain, west on the Hilliard Drain to S. Pennsylvania Ave. south on S. Pennsylvania Ave. to Maplehill Ave., west on Maplehill Ave. to the point of beginning.

Precinct 16

Starting at the intersection of the branch of Sycamore Creek and the Norfolk Southern Railroad Track go southeast on the Norfolk Southern Railroad Track to E. Jolly Rd., east on E. Jolly Rd. to Collins Rd., north on Collins Rd. to Dunckel Rd., west then south on Dunckel Rd. to E. Cavanaugh Rd. northwest then west on E. Cavanaugh Rd. to Aurelius Rd., north on Aurelius Rd. to Forest Rd., west on Forest Rd. extended to Sycamore Creek, southwest on Sycamore Creek to the point of beginning.

Precinct 17

Starting at the intersection of E. Mt. Hope Ave. and Aurelius Rd., go south on Aurelius Rd. to E. Cavanaugh Rd., go east then southeast on E. Cavanaugh to Dunckel Rd., north and then east on Dunckel Rd. to Lansing's City Limits, north and then various directions along Lansing's City Limits to E. Mt. Hope Ave., west on E. Mt. Hope Ave. to the point of beginning.

Precinct 18

Starting at the intersection of W. Jolly Rd. and S. Washington Ave., go south on S.

Washington Ave. to W. Northrup St., east on W. Northrup St. and E. Northrup St. to S. Cedar St., southeast on S. Cedar St. to I-96, east on I-96 to Lansing's City Limits, beginning northward follow Lansing's City Limits to E. Jolly Rd., west on E. Jolly Rd. to the point of beginning.

Precinct 19

Starting at the intersection of W. Northrup St. and S. Washington Ave., go south on S. Washington Ave. to I-96, east on I-96 to S. Cedar St., northwest on S. Cedar St. to E. Northrup St. west on E. Northrup St. and W. Northrup St. to the point of beginning.

Precinct 20

Starting at the intersection of I-96 and S. Washington Ave. go south on S. Washington Ave. to W. Willoughby Rd. and Lansing's City Limit, beginning easterly along Lansing's City Limit follow Lansing's City Limit to Aurelius Rd., North on Aurelius Rd. to I-96, west on I-96 to the point of beginning in addition to all land contained within a P.A. 425 agreement with Alaieton Township where voters are designated as Lansing voters.

Precinct 23

Starting at the intersection of W. Mt. Hope Ave. and Moores River Dr. go southwest on Moores River Dr. to S. Waverly Rd., south on S. Waverly Dr. to Glasgow Dr., east on Glasgow Dr. to S. Deerfield Ave., south on S. Deerfield Ave. to Victor Ave., east on Victor Ave. to Pleasant Grove Rd., north on Pleasant Grove Rd. to W. Mt. Hope Ave., west on W. Mt. Hope Ave. to the point of beginning.

Precinct 24

Starting at the intersection of Glasgow Dr. and S. Waverly Rd., go south on S. Waverly Rd. to W. Holmes Rd., east on W. Holmes Rd. to Pleasant Grove Rd., north on Pleasant Grove Rd. to Victor Ave., west on Victor Ave. to S. Deerfield Ave., north on S. Deerfield Ave. to Glasgow Dr., west on Glasgow Dr. to the point of beginning.

Precinct 25

Starting at the intersection of Victor Avenue and Pleasant Grove Rd., south on Pleasant Grove Rd. to W. Jolly Rd., east on W. Jolly Rd. to S. Martin Luther King Jr. Blvd., north on S. Martin Luther King Jr. Blvd. to Victor Ave., west on Victor Ave. to the point of beginning.

Precinct 26

Starting at the intersection of W. Holmes Rd. and Churchill Ave., go south on Churchill Ave. to Glenbrook Dr., east on Glenbrook Dr. to Wainwright Ave., south on Wainwright Ave. to Risdale Ave., east on Risdale Ave. to Ballard Rd., south on Ballard Rd. to W. Jolly Rd., east on W. Jolly Rd. to Pleasant Grove Rd., north on Pleasant Grove Rd. to W. Holmes Rd., west on W. Holmes Rd. to the point of beginning.

Precinct 34

Starting at the intersection of the Grand River and northbound S. Martin Luther King Jr. Blvd., go south on S. Martin Luther King Jr. Blvd. to W. Mt. Hope Ave., east on W. Mt. Hope Ave. to S. Washington Ave., North on S. Washington Ave to Moores River Dr., west on Moores River Dr. to the extension of parcel 33-01-01-21-328-311, north on the extension of and on parcel 33-01-01-21-328-311 to the Grand River, west on the Grand River to the point of beginning.

Precinct 35

Starting at the intersection of W. Saginaw St. and Lansing's City Limit, go south, west, southwest, east, and northeast on Lansing's City Limit to the Grand River, east on the Grand River to northbound S. Saginaw St. to the Grand River, north on the Grand River to E. Cesar E. Chavez Ave., west on E. Cesar E. Chavez Ave. and continue to W. Cesar E. Chavez Ave. to N. Pine St., north on N. Pine St. to W. Willow St., west on W. Willow St. to the point of beginning.

Precinct 38

Starting at the intersection of the Grand River and E. Cesar E. Chavez Ave., go northwest and southwest on the Grand River to Lansing's City Limit, follow Lansing's City Limit southward to W. Saginaw St., east on W. Saginaw St. to Westmoreland Ave., north on Westmoreland Ave. to W. Willow St., east on W. Willow St. to N. Pine St., south on N. Pine St. to W. Cesar E. Chavez Ave., east on W. Cesar E. Chavez Ave. and continue to E. Cesar E. Chavez. to the point of beginning.

Precinct 39

Starting at the intersection of N. Waverly Rd. and Delta River Dr., go south on N. Waverly Rd. to Lansing's City Limit, follow Lansing's City Limit east and then north to the Grand
